GENERAL RULES

AUTHORITY

The curriculum for the Advanced Postgraduate Diploma in Music is laid down under the authority of Executive Order No. 1476 of 01 October 2020 concerning education programmes at the Danish academies of music and the Opera Academy in the area of the Danish Ministry of Culture. This curriculum applies to all current students enrolled after 01.08.2018. Students enrolled at an earlier time may be subject to transitional rules.

ECTS

The Advanced Postgraduate Diploma in Music is a full-time course of study corresponding to 120 ECTS points. 60 points in the European Credit Transfer System (ECTS) corresponds to one year of full-time studies. The programme is organised as a full-time study programme within a two-year timeframe.

ENTRANCE REQUIREMENT AND ENTRY EXAMINATION

The entrance requirement for the programme is a completed Master's programme from an academy of music, or equivalent qualifications, and a passed entrance examination. The decision on whether to admit an applicant is taken by the Academy/Royal Opera Academy on the basis of a concrete assessment of the applicant's abilities and skills, undertaken by the Academy/Royal Opera Academy and one or more external moderators appointed by the Danish Ministry of Culture. The requirements of the music profession are also taken into consideration, as well as the need to attain an appropriate balance of instruments and voices.

Applicants who have concluded a Master's or soloist programme at the Academy or the Opera Academy can only be admitted to a new Master's or soloist programme if a study place is vacant. The same applies to applicants who have been enrolled twice previously in a Master's or soloist programme without having taken the final examination.

INTERNATIONAL FEE-PAYING STUDENTS

The study programme is not available to fee-paying students.

TITLE AWARDED

Graduates of the programme are entitled to use the Danish title solist (speciale). The English-language title is: Advanced Postgraduate Diploma in Music (specialisation)

PURPOSE AND COMPETENCY PROFILE OF THE PROGRAMME

The purpose of the Advanced Postgraduate Diploma in piano specialising in opera repetiteurship is to qualify the student for employment in Danish and international opera companies and opera houses.

Knowledge

- In-depth knowledge and understanding of artistic practice within the subject area, on the basis of internationally-recognised artistic practice and artistic research, and the ability to independently handle challenges and issues of an artistic nature.
- In-depth understanding of studied works that supports and develops the student's artistic profile on the basis of extensive repertoire knowledge.
- Broad knowledge of the music industry and cultural life, together with an understanding of music performance at the highest professional level, with special emphasis on the working practices of an opera house.
- Specialised knowledge of methods and tools to solve artistic and rehearsal-related challenges.
- Specialised knowledge of the opera industry and of artistic practice at the highest professional level, together with the ability to independently undertake one's own career planning.

Skills

- Mastery at the highest professional level of instrumental-technical, rehearsal-related and artistic skills associated with employment as an opera répétiteur.
- Mastery of the artistic subject at the highest professional level, including a well-developed, confident style understanding.
- The ability, in connection with the student's artistic practice, to analyse and reflect upon approaches or techniques within the study area and develop new ones where relevant.
- Skills to participate in specialised artistic and technical discussions at international level in collaborative artistic projects.
- Skills to present oneself to partners, employers and the media.

Competencies

- Competency, at the highest professional level, to lead artistic/rehearsal-related processes in complex and unpredictable work situations with one or several singers, independently or in collaboration with an artistic director/conductor, and the ability to develop new solutions in the encounter with complex challenges.
- Competency to take independent responsibility for one's own professional development and to expand one's own artistic perspective and identity.
- Competency to apply musical, communicational and vocal/instrumental knowledge, and to independently undertake responsibility for extensive rehearsal processes at the highest professional level.

• Competency to independently and with artistic integrity initiate and enter into professional artistic collaborative projects at national and international level as an opera répétiteur, orchestral or ensemble musician.

1. PRINCIPAL STUDY

(1st-4th semester)

ARTISTIC PRINCIPAL STUDY

(1st-4th semester)

Learning content:

In the Advanced Postgraduate Diploma in Music specialising in opera repetiteurship, teaching in the principal study primarily takes the form of individual coaching. At the commencement of the programme, it is assumed that the student possesses a sufficient degree of technical and musical maturity to allow the teaching to focus on the artistic and interpretational aspects of the music and the practical aspects of the profession. A central part of this work is to foster the student's artistic identity, with a view to enabling the student to develop the distinctive qualities that are an essential part of being an opera répétiteur. On the basis of the student's specific talent, the student and the teacher of the principal study jointly organise the repertoire and supplementary disciplines to be studied during the programme, such as conducting, recitative, score playing, sight reading, singing and language.

The teaching is organised in such a way that the student works with teachers who mainly have a background in didactic/teaching work (e.g. at the Academy) or in professional practice (e.g. at an opera house). The study programme is developed and organised on an ongoing basis in close collaboration with the Royal Theatre.

Compulsory internship forms part of the regular teaching in the principal study, in the form of rehearsal procedures in one or more performances of the Royal Danish Opera, as well as participation in selected projects of the Opera Academy and the requirement to be available for sign-up slots for students in the Young Artist Programme of the Opera Academy (see under "Internship").

The student will be assigned a mentor from the Royal Danish Opera at the Royal Theatre who will meet with the student for at least one hour each semester to discuss the student's study progress and professional profile. The mentor may be one of the student's principal study teachers.

To a reasonable extent and at appropriate notice, the student may be summoned by the student's teachers to attend or observe selected rehearsal sessions or examinations at the Royal Danish Opera, the Royal Theatre or the Opera Academy.

To the extent possible, the student may attend classes in the subject in the Master's Programme in Piano Specialising in Repetiteurship at RDAM.

Teaching and learning methods:

Individual and class teaching.

Examination regulations:

Graduation project: Stage rehearsal with piano¹

After the fourth semester

Learning outcomes

At the conclusion of the subject, it is expected that the student will:

• Master, at the highest professional level, the artistic methods, tools and expressions of opera repetiteurship, and be able to realise and express a personal artistic identity, independently and/or in collaboration with an artistic director/conductor.

Examination form and duration

Practical test

Moderation and assessment

The final graduation project is assessed by an external examiner who represents a high degree of specialised knowledge in opera repetiteurship, as well as by an internal examiner, who must not be the student's principal study teacher. The examination is assessed in accordance with Executive Order no. 1244 of 11 December 2009 on the Study Programmes at the Academies of Music and the Opera Academy. The assessment awarded is Approved/Not approved, supplemented by a written statement on the student's technical standard on the basis of an overall assessment of the graduation project.

Permitted examination aids

Not relevant.

Special provisions

The student submits a project application containing the date, time and place of the final graduation project. The project application must be signed by the teacher of the principal study.

The deadline for submitting the project application is at least three months before the project is held.

It is the student's responsibility to ensure that the project application is signed by the teacher and that the material is submitted on time.

It is the Academy's responsibility to convene and remunerate the moderators.

The internal moderator is responsible for collecting the assessment sheet, etc., from the Events Department.

INTERNSHIP

(1st-4th semester)

Learning content

In dialogue with the Royal Danish Opera via the Director of Studies at the Royal Theatre, the internship is agreed between the student, the student's principal study teacher and the Director of Opera at the Royal Theatre. The size and nature of the assignment will depend on the student's prerequisites and the current repertoire in the season in question.

Teaching and learning methods:

The student participates in the rehearsal processes of one or more performances and is summoned to rehearsals and possible performances at the Royal Danish Opera via the production manager for the Opera at the Royal Theatre. The student also participates in selected projects at the Opera Academy, and is required to be available for sign-up slots for students in the Opera Academy's Young Artist Programme.

Examination regulations:

Learning outcomes

At the conclusion of the subject, it is expected that the student will:

• Be able to meet the artistic and practical requirements of working with opera production at the highest professional level.

Examination form and duration

Participation in rehearsals and possible performances.

Moderation and assessment

The internship is assessed with internal moderation, consisting of the Director of Studies at the Royal Theatre and the head of the repetiteurship programme at RDAM. The grade awarded for the internship is pass/fail.

Permitted examination aids

Not relevant.

Special provisions

The internship is arranged in dialogue with the Royal Danish Opera via the Royal Theatre's Director of Studies between the student, the student's principal study teacher and the Director of Opera at the Royal Theatre. The size and nature of the assignment will depend on the student's prerequisites and the current repertoire in the season in question.

ENTREPRENEURSHIP

(1st-3rd semester)

Learning content:

The starting-point for the teaching is the student's independent artistic and musical work. The student will gain insight into entrepreneurship as a mindset that supports a viable working life and career. The teaching focuses on selected subjects within the field of entrepreneurship, and is based on business models that can be useful in artistic contexts. In the teaching, the student is introduced to tools, methods and knowledge that can be used in a professional career within an international employment market/cultural life.

Teaching and learning methods:

Class teaching, presentations and exercises. Parts of the teaching may take the form of workshops and project tuition.

Examination regulations: After the third semester

Learning outcomes

At the conclusion of the subject, it is expected that the student will:

- Possess knowledge of the field of entrepreneurship, and be able to reflect on the link with one's own work as a musician/entrepreneur in an international context.
- Be able to analyse, develop and communicate the value potential of artistic projects and take independent responsibility for one's own career.
- Be able to assess and utilise entrepreneurial tools in a professional context.
- Be able to independently assume responsibility for the development of major musical projects, and communicate and discuss these with peers and non-specialists.

Examination form and duration

Written assignment of 5-10 standard pages. One week is allowed for the assignment.

Moderation and assessment

The examination is assessed by an internal moderator and the student's own teacher. A single combined grade is awarded under the currently applicable marking scale.

Permitted examination aids

All examination aids are permitted.

Special provisions

The student is responsible for ensuring that the assignment is collected on time from the Study Administration and submitted on time. The assignment must be submitted electronically.

GUIDELINES FOR EXAMINATION AND ASSESSMENT

The student submits a project application containing the date, time and place of the final graduation project. The project application must be signed by the teacher of the principal study.

The deadline for submitting the project application is at least three months before the project is held.

In the event that the student cancels the final graduation project due to illness, or for some other reason, this must be done by written application to the Events Department at least three months before the scheduled date.

If the cancellation occurs less than three months before the scheduled date for the final graduation project, a new date will be agreed with the Academy and the Royal Danish Opera.

Deadlines for the submission of examination materials

It is the student's responsibility to ensure that the project application is signed by the teacher and that the material is submitted on time.

Moderation and assessment

The assessment awarded for the final graduation project is Approved/Not approved, supplemented by a written statement on the student's technical standard on the basis of an overall assessment of the project.

The final graduation project is assessed by an external examiner who represents a high degree of specialised knowledge in opera repetiteurship, as well as by an internal examiner, who must not be the student's principal study teacher.

The examination is assessed in accordance with Executive Order No. 1476 of 01 October 2020 concerning education programmes at the Danish academies of music and the Opera Academy.

The internal moderator is responsible for collecting the assessment sheet, etc., from the Events Department.

Assessment procedure

The statement and assessment are usually compiled on the day after the final graduation project. The examiners are assisted by the pro-rector or by a deputy for the pro-rector, who is responsible for transcription of the statement, signatures etc. The assessment is then forwarded to the examinee as soon as possible, accompanied by a standardised reference to the rules for appeal. The deadline for appeals, i.e. the formal date for the award of the assessment, will be stated here.

Appeal

The student may appeal against the result of a test or examination in accordance with Ministry of Culture Executive Order No. 1476 of 01 October 2020 on Complaints Relating to Tests and Examinations at the Academies of Music and the Opera Academy.

The student may appeal in relation to:

- The examination basis (examination questions, assignments, etc.) and its relationship with the examination requirements
- The conduct of the examination
- The assessment

The student must submit the appeal to the Academy no later than two weeks after the results of the test or examination are announced. The appeal must be made in writing and must state the reasons for the appeal.

Participation in teaching and compulsory attendance

The teaching is regarded as an offer in which students are expected, but not obliged, to participate. In all cases of absence, the student must ensure that the Academy and the Royal Danish Opera are notified. Absence without notification will be considered a breach of the study place and may be punished by exclusion from teaching at the discretion of the teacher.

Attendance at non-timetabled teaching such as orchestral playing, concerts, choral and ensemble singing, musical drama, courses and master classes is however always obligatory.

The rules for student attendance at teaching are stated in the Students' Regulations, the Regulations for Concerts and Non-timetabled Teaching, and the Disciplinary Guidelines for students at the Royal Academy of Music, all of which are available on the Academy's intranet.

Disciplinary measures

The rules for disciplinary measures for students at the Royal Academy of Music are available on the Academy's intranet.

The disciplinary measures apply to all students at the Royal Academy of Music, and students are therefore required to be familiar with and keep themselves informed of the rules.
